
Mule Deer Presentation by Tony Wasley, NDOW

Tony has a 90 minute presentation that is very informative. A half hour presentation at our lunch would not do him or the topic justice so we have set this up for Thursday evening August 9th at Arizona Charlie's up stairs in a banquet room. Sportsmen Pay for Conservation

America's millions of licensed hunters are conservations army, about 14.5 million strong. So are America's 50 million anglers. They pay for a large percentage of conservation programs, endangered species protection, habitat preservation and just about everything else. While environmental groups are busy suing the US Fish and Wildlife Service to force it to add a snail or a titmouse to the Endangered Species List, America's hunters are busy contributing more than \$30 billion annually to the US economy and supporting more than 986,000 jobs, according to the 2001 US Fish and Wildlife Services National Survey of Fishing, Hunting and Wildlife-Associated Recreation.

While environmentalists are filing lawsuits to force the Environmental Protection Agency to regulate greenhouse gases from automobiles, sportsmen are busy financing (more than 1.5 billion per year) state and federal conservation programs that benefit all Americans.

While animal "rights" activists are breaking into ferret farms to save the furbearers from becoming fashionable coats, hunters are financing state wildlife agencies; in fact, unlike other state agencies, the fifty state wildlife departments receive little support from taxes paid by the general public; rather, the majority of their operating funds (an average of about 75%) comes from hunters and anglers.

While environmental groups receive credit for esoteric achievements in the courts, sportsmen are paying, as they have for generations, nearly all the bills for practical wildlife conservation-and paying them not just for their own benefit, but for all Americans.

The first resident hunting licenses were issued in 1895 by Michigan and North Dakota, by 1910 revenue from hunting licenses was being collected in 33 states. Through these license fees and special excise taxes on hunting and fishing equipment, sportsmen currently contribute more than \$4.7 million each day for the benefit of wildlife. By paying Pittman-Robertson surtaxes on guns, ammunition and other items, hunters sent \$294,000,000 to state conservation programs in 2005. This tax combined with Dingell-Johnson taxes on fishing equipment and motorboat fuel came to more than \$523 million in 2005. All of which goes to state fish and wildlife agencies to support fish and wildlife conservation and education programs-including buying critical habitat for wildlife.

In fact, both the Dingell-Johnson and Pittman-Robertson taxes have sent more than \$5 billion to conservation. That means that since establishment of these critical programs, in 1950 and 1937 respectively, anglers and hunters have paid more than \$10 billion for fish and wildlife management. And that's just counting those two excise taxes. The archery community entered the picture in 1972 with the passage of the Dingell-Goodling Bill, specifying 11% excise tax on archery equipment. The proceeds, which now amount to some \$25 million per year, are also used for wildlife restoration and hunter safety training.


Its really astounding how much hunters are doing when you realize that only 6% of the US population 16 years old and older hunted in 2001. Hunters and fishermen spent a total of \$70 billion in 2001 (\$36 billion on fishing, \$21 billion on hunting, and \$14 billion on items used for both hunting and fishing) according to the US Fish and Wildlife Service. So sportsmen contributed \$54 every second, \$3,240 every minute, \$194,400 every hour and \$4.7 million every day. This adds up to \$1.7 billion in 2001. And environmentalists contributed??????

Thanks for paying your own way.

RESULTS OF THE BLACK POWDER SHOOT

The Black Powder shoot was held last month at the Clark County Shooting Complex. After alittle confusion on the part of honcho Mr Patterson the date was clarified and numerous emails were sent to make sure everyone knew of the change in date. Fourteen members showed up on a windy morning to shoot the smoke poles. This is a great shoot to try a unique weapon. Many shooters have never shot black powder or only once a year at this event. Many don't own their own equipment which is fine, several members share their guns and the club provides all the supplies. This is a good opportunity to try something new. I don't know how many years I've been the honcho for this event, 8 or 10 years now and every year we have some sort of "incident". I need to provide better instruction. A step by step list on the procedure to load and shoot these guns. Step 1. powder, Step 2. bullet, Step 3. primer, Step 4 shoot, Step 5 run a wet patch down the barrel.

The incident has usually been Ken Johnson skipping one of the steps. Sometimes the steps need to be expanded on, For John Gorman its somewhere between step 2 and step 4 "remove the ramrod from the barrel". This years incident was Bob LePome forgetting step 1 and proceeding directly to step 2. Ken was able to remember the steps this year but he had an incident anyway....his gun simply would not fire. Neil Dille consistently skipped step 5 and his accuracy suffered greatly, he ended up breaking his gun trying to get it apart to finally clean it. Tony DeFonte had an incident too, after trying to help Bob with his stuck bullet in the barrel he used his ram rod (with a very sharp threaded screw attached to the top). The scar on his thumb will be a reminder to remove the sharp screw prior to trying to push a bullet into his own gun. Do you notice a common thread with all these "incidents"? I do. All the incidents are committed by individuals over the age of 65. I may have to change the next Black Powder shoot to have an age limit placed on the participants.



Mike Taylor using my gun came in first with a score of 36. John Fenner was second with a 35 he used a borrowed gun too, (See their targets above), these are pretty big groups for only 50 yards yet they were the best shooters. If you think you can do better than that, show up next time for the shoot, its a lot of fun. Neil Dille and Mike Reese each had 32 and Lorenz Zbyszek and I each had 31 points. Lewis Class money was paid out to 7 shooters. New member Larry Cusimano joined at the spring feast and got second place money in the second flight. He had placed in the money at the spring feast but as a non-member was not paid in the Lewis Class, he's a believer now. Others that placed in the money were Bob LePome and Clayton Philipp. See the Marksman of the Year standings on the back page.


