

My home made rating system for the hunt is as follows on scale of 1-10 Ten being best: Comradely 10, Lodging 9, Food 7, OVER ALL 9.5







November 16th Turkey shoot at CCSC

The match is 20 rounds total (10 rounds pistol and 10 rounds rifle **OR** 20 rounds rifle **OR** 20 rounds pistol, shooters choice) Total score is 20 hits. One shot per animal. 10 Animals per bank. Two minutes for 10 shots. You may start at any distance. Animals must fall down to be counted as a hit. You must have someone else spot your shooting and score for you. When completed, turn in your score cards to the Honcho. 22 LR ammo only. .22 mag OK for rifle only. Any sights. Offhand unsupported shooting only. No slings, no braces, no back packs, no leaning on tables. We have the range from 8am-12, sign up at 8 shooting at 8:30. This is a Marksman of the Year event. Event cost will be \$20.


