LVWW Archery Shoot 2018

A concern expressed by some after the 2017 Las Vegas Woods and Waters Archery Shoot was that it wasn't realistic enough. It was in fact shot in doors, in a densely populated metropolitan area, at pretend paper animals, in a climate controlled family friendly environment. It also featured a replication on a long standing LVWW tradition – poker (a paper target with 52 cards on it).

So, to reduce the likelihood that a simulated gut pile wasn't imaginable, our 2018 archery shoot was held outdoors at the *Clark County Shooting Complex* archery range. Rain, snow, famine, stampede, or ex-wives would not stop this event. Oh did I leave out wind? No – it showed up.

When I picked the start time of 10:00 a.m. (knowing it was mid-winter) I figured that would give shooters time to load up on coffee as the morning warmed up a bit. That worked perfect. It also allowed the wind speed to accelerate as the sun climbed higher into the sky. It seemed each arrow knocked added one more MPH.

Any shooter of anything (except for sissy indoor shooters) knows that whatever the projectile is, wind will affect the shot. The problem with bow and arrow shooting, is that the gales will also blow about the archer. And so it did. No benches, no sand bags, no barricades. Even using Clayton Philipp as a wind break didn't work.

Targets were mixed up starting with traditional round paper targets at 20 yards, then 3D targets including two deer (one at 20 yards and one at 30 yards), and a big horn ram at 40 yards. The guys that shot the longer distances first seem to score higher before the wind speed increased. A final one 10 point arrow was to be a coyote at an unspecified distance. The only place we could anchor the miniature paper howler was on the 20 yard line.

When the last arrow was packed away, President Dave Famiglietti won the coin and the first 10 points of the year. Jeff Boatright came in second. Al Schoelen walked away with third.

Only six shooters came out. Makes me wonder why. With the new points system in place since last year, that left 4, 3, and 2 points left on the table. One arrow in the dirt from a kids bow would have netted extra points. Last year the *Angler of the Year* was decided by one point – just say'n.

Thank you new member Ken Swierski for helping with target and coffee set up, and Lori Willits for keeping the books and seeing the Lewis money made it into the right hands.



CHERRY CREEK RANCH COYOTE HUNT

This year's coyote hunt will be held at the Cherry Creek Ranch on **Saturday, April 7th**. The ranch is located about 60 miles north of Ely, see map. The ranch is primitive to say the least, it consists of 640 acres of mostly grazing land. There is no land power, we use generators to power our camp trailers, and no running water for those of you that will be bringing up your trailers. You can bring a tent (snakes aren't out yet in April) or stay in Ely and drive out (about an hour



drive). The best way to enjoy this event is to bring a trailer or hook up with someone who is. I will be at the ranch starting Thursday so you can come up as early as Thursday. You should be at the ranch Friday so you can start your coyote hunt early Saturday morning, that's when we hear them raising hell just at the south end of the property.

You can hunt all day Saturday or after a morning hunt you can come back to the ranch where we will have a clay bird thrower set up for some trap shooting and maybe a fun, long range target range with 200, 500 and 1,000 yard targets.

Saturday night we will build a camp fire and have steak, beans and potatoes for dinner. We don't have running water but we do have a pool table and poker tables for those who wish to lose some money. So bring your favorite coyote rifle, your shotgun and long rifle and your favorite beverages and have some fun living like Jeremiah Johnson.

I will be leaving the ranch on Monday, so you are welcome to stay until Monday morning.
