# July 11 8am Center Fire Pistol Shoot at CCSC honcho Ralph Willits

Ralph Willits is the honcho and has put a lot of thought into the shoot, format, scoring, and safety for the event. This is center fire only. NO MAGNUMS, no hollow points, no .45s (ACP or LC), up to .44 special caliber. Revolvers or semi-autos; IRON sights for this competition; no laser or optic sights (fiber optic sight ok).Cost is \$20 per shooter, be prepared to shoot 100 rounds, bring your own gun and ammo. Some may only shoot 12 shots if eliminated early. Random pairing of shooters will go head to head in a double elimination competition.

The competition: This will be a "Dueling Tree." There will be 3 round discs on each side of the tree (total of 6). From the LOW READY position, each shooter will fire at the discs on his side to swing each to the other shooter's side. The round will be finished when the winner has all 6 discs on his



adversary's side. If no shooter can get all six discs to his opponent's side, the winner will be determined by how many are on the other side after 1 minute, or both have run out of ammo. If there is a tie at this stage, a 1-3 round shoot off will done to determine who goes on to the next round.

For Lewis Class that aren't in the top 4, ranking will be by how many total targets were on the opponent's side each time they were eliminated. If there is still a tie, there will be a shoot off for ranking. When you win each round, you will of course score more total points.

### **Black Powder shoot results**



Don Turner provided the group with a short history lesson about early black powder shooting matches. It seems a string was used to measure the distance from the bulls eye to each hole in the target. The shortest string represents the shooter with most shots closest to the point of aim. And thus the term "string of shots" was coined. Honcho Brian Patterson liked the idea and decided it would be a good visual to see everyone's "String", note the photo above, notice Mike Reese (holding the baby) has his string touching the ground. As a penalty if one of your 5 shots did not even hit the 1 foot square paper target you were assessed a 24" shot (twice the size of the paper). Mike only had 3 shots on target, he missed the paper TWICE, so he was penalized 4 FEET of string.

The crazy thing was there was a tie between Michael Reese and Jeff Jorgensen for 1<sup>st</sup> & 2<sup>nd</sup> place. So we had them shoot 1 shot at 100 yards to break the tie....nope they tied again! 1 more shot each and finally Jeff was the winner. Jorgensen 1<sup>st</sup>, Michael Reese 2<sup>nd</sup>, Brian Patterson 3<sup>rd</sup>, Brian Cimperman 4<sup>th</sup>, Chris Griebling 5<sup>th</sup>, Don Turner 6<sup>th</sup>, Tony Perkins 7<sup>th</sup>, Mike Taylor 8<sup>th</sup>, John Mitteness 9<sup>th</sup>, Jeff Bryant 10<sup>th</sup> all got Marksman of the Year points added the rest of the shooters each got 1 point each. Lewis Class money went to the top three shooters \$60,\$40, & \$20 as well as Talyor \$60, Mitteness \$40 & Bryant \$20 in the second flight.



See the photo at the left: that's how close the difference was for  $3^{rd} \& 4^{th}$  place between Brian Patterson and Brian Cimperman only 1/16" of an inch. It was pretty amazing to see just how close the competition was.

We had 14 shooters attend the match, the club provided coffee and donuts along with all the shooting supplies. If you don't have a black powder gun you can borrow one....ask Jeff Jorgensen he won the event with a borrowed gun (which has been done several times now).

## 22 Rifle Silhouette Shoot Results

Everyone has fun at our silhouette shoots, there is something different about knocking down steel vs punching holes in paper. Honcho Don Turner had the course set with 20 targets at various ranges, 25-50-75&100 yards. The format is straightforward; 20 targets, 30 rounds of ammo and 3 minutes to hit them all or run out of shells. Let's just say the time frame is not an issue, however no one was able to hit 20 targets with 30 shots. .22's at 100 yards offhand can be a challenge. For an extra \$5 you could shoot again to better your score, however better or worse your final score would be official and count toward Marksman of the Year and Lewis Class. About half of the shooters went to the line a second time, about half of them got a better score about half did not.


There were a few ties that were settled in a head to head 1 shot hit or miss format at 100 yards. This is a fun spectator sport to watch the pressure mount as you only get 1 shot going back and forth.

We had 22 shooters show up for the completion. Jeff Bryant got first place shooting 16 targets, Bruce Young was 2<sup>nd</sup>, Mark Forsstrom 3<sup>rd</sup>, Michael Reese 4<sup>th</sup>, Mike Stokes 5<sup>th</sup>, Brian Patterson 6<sup>th</sup>, Dan Zelna 7<sup>th</sup>, Mike Lussier 8<sup>th</sup>, Randy Peters 9<sup>th</sup> and Mike Reese was 10<sup>th</sup>. Then, it was time to see who won Lewis Class money. We had three flights and paid three places in each flight so 9 of the 22 shooters got paid. Bryant \$60, Young \$40, Forsstrom \$20 in the first flight, Lussier \$60, Peters \$40, and Mike Reese \$20 in the second flight and Jeff Jorgensen \$60, Mike Taylor \$40 and Robert Gaudet \$20 in the third flight.

## Wildlife board is unbalanced

The Sun's compelling June 14 editorial, "Unregulated trophy hunting not only cruel but also bad for the environment," exposed the underbelly of cruelty and anti-environmental practices.

State law clearly indicates that wildlife belongs to all Nevada residents, as do our public lands.

The Nevada Board of Wildlife commissioners, appointed by the governor, supposedly establish policies and regulations for "the preservation, protection, management and restoration of wildlife and its habitat."

However, the nine members are composed, by statute, of one farmer, one rancher, five hunters/ trappers/anglers, one conservationist and one member representing the general public.

Farmers and ranchers together make up less than 1% of the state's approximately 3 million residents.

Licensed hunters, trappers and anglers comprise less than 5% of the state's population, yet represent over half of the commission. These commissioners must purchase wildlife-killing licenses in three of the four preceding years.

Why are those who seek to kill the public's wildlife presumed to know what is best for their long-term welfare? Can they really "preserve and protect" the wildlife they wish to kill? Their policies and regulations show alarming disregard for our wildlife's health and prosperity.

Then the dismal realization dawns: The people who truly desire to protect and restore wildlife – the general public and conservationists – make up only 22% of the commission yet constitute 95% of Nevada's population.

The commission is lopsided. It should reflect Nevada's population — the 95% that doesn't buy wildlife-killing licenses. Only then will there be real protection for our wildlife. **Stephanie Myers,** Las Vegas another. John Soltesz, Logandale

# Hunters belong on wildlife board

The June 21 letter "Wildlife board is unbalanced" questioned why a small percentage of Nevada's population — hunters and fishermen — hold a majority of the seats on the state's Wildlife Commission.

The question is the answer: They care about the resource. They pay to hunt Nevada. There are no guarantees but they still pay.

Licenses provide Nevada badly needed funds, which help employ environmentalists, conservationists and rangers. Sportsmen rely on wildlife managers for input year-round and vice versa.

Who we don't need making decisions on a wildlife commission are citizens who are not outdoorsmen and are in the field sporadically. They probably learn from episodes of Bear Grylls' TV shows or by stalking their potbellied pig through the house.

Nevada's sportsmen volunteer their time and money all year and wherever necessary. They deliver feed and water to starving wild horses, elk, deer and sheep. They repair dams, roads and infrastructure out of their own pockets, which enhances everyone's experience. They are the best prevention from polluters, scofflaws and poachers. They serve as multiple eyes and ears for wildlife enforcement.

Consider: Who is on the Nevada Boxing Commission, the Board of Realtors, the Gaming Control Board, the Allegiant Stadium Authority or, for that matter, the COVID-19 committee created to bring back Vegas? They are people who walk the walk, have a vested interest and are willing to share their time and knowledge with the rest of us.

Sportsmen should be on the wildlife committee and we need more of them, not fewer. **Craig Wright**, *Las Vegas*  Thank you Craig Wright for taking time to respond to the editor and speaking up for hunters. Ms Myers is a non-consumptive user that is out to stop all hunting & trapping in Nevada. Ms Myers refers to a June 14 article written by her cohort Fred Voltz.

They both are constant figures at all the local CAB and State Wildlife Commission meetings.....you should be too. They tend to speak for "you" when you are not present.

These folks need to be educated on the north American model of wildlife management that is envied around Hunters, trappers and the world. fishermen have taxed themselves to support wildlife. The Pittman-Robertson Act established in 1937 places an 11% tax on all shooting supplies, guns, ammo, etc. This money does not go into the US Treasury but to the Secretary of the Interior to be used by each state for wildlife management. They use a formula based on state size and number of licensed hunters. The state must then spend the money on wildlife management, research and This along with hunting habitat. fishing license sales is how NDOW is funded, not by Ms Myers and her friends.

So who should be involved in making decisions about wildlife? Those that support wildlife with their wallet. Like Craig mentions, do you want pilots making decisions about air travel or the general public? Do you want doctors making decisions on how to govern medicine or the general public? Sure the general public should be represented to give input but the majority of those in position to make decisions should be those that know the most about the subject and what is needed for the best of the profession or resource and the public.
