1st annual Don Turner Memorial Turkey Shoot

When: Saturday **November 13** Where: CCSC Training Center 100 yard range Time: 12 Noon-4pm

Event format:

1. 22 long rifle, any gun type as long as its 22lr only! (No mag or wmr's) 2. 1st round will be 5 chickens @ 15 yards and 5 Turkeys @ 25 yards. You will have 2 min to shoot 10 shots at the steel targets. One point per knocked down target. This round will be shot from the standing position 3. 2nd round will be a paper splatter turkey target @ 50 yards.10 shots at target in 2 min. Score will be counted as hits on vital areas of turkey. This round will be shot from a sitting position at the bench and you can use your elbows for support.

4. 3rd round. One balloon at 100 yards. "2 shots only" Bust the balloon and 10 points added to score. Shot same as round 2 from bench.5. Buy back: After first round is shot you can reshoot this round for \$ 5.00 the buy back score is the score used.

Wyoming Back County Elk Hunt by bpatterson

I won a back county Wyoming elk hunt in July 2019 with Pro Memberships Sweepstakes. They have donated memberships to our banquet and I have promoted this to the club a few times over the years, 9 or 10 LVWW members have also won big hunts. I finally got to go on the hunt in Oct 2021. As fate would have it, I had been to this exact camp 4 years ago when Barclay Swan won the hunt and I was able to go as his cameraman. That previous trip had me fully aware of what was in store, a 31 mile horse back ride into some VERY remote wilderness located just outside Yellowstone National Park. Barclay was unsuccessful 4 years ago and I planned to avenge his trip.

We left the trailhead at a leisurely hour of 8am. A looong ride through some spectacular scenery included seeing a black

bear, a grizzly bear and climbing some 4,500 feet over the 10,491 foot Deer Creek Pass. Snow shovels are located in several locations along the switchbacks over the pass, used in case a snow storm blocks the trail. Sections of the trail are just a couple feet wide with a vertical fall of over 1000 feet. No falling asleep on your horse. We arrived at camp 10.5 hours later at 6:30pm just in time for dinner. Everyone was a "little" sore and ready for bed in short order, as roll call and breakfast would be at 5am sharp. There were three other hunters in camp. Each of us had our own guide and would head out in separate directions in the morning.


The whole camp staff had been in the back country since late July setting camp, cutting firewood and scouting. When I say cutting firewood, I mean ALL by hand. NO POWER tools allowed in the wilderness, no gas, no generators, no electrical items. Two man cross buck saws and ax to make every stick of firewood. Just a few years ago "artificial" light was finally allowed....this means flashlights, headlamps and propane lanterns are now "ok". No wheeled devises are allowed. No bike, no wheel barrow, no cart, NO WHEELS! A few years ago the camp had constructed a wheel barrow out of wood (think Gilligan's Island) to move heavy items around camp.....when the Forest Service stopped by for an inspection it had to be dismantled and never used again.



Bears and bear safety are a constant concern in this remote location. The camp cook was very particular about camp cleanliness and food storage. No snacks allowed in the tents, not even your person shave kit with toothpaste and lotions, they had to be locked up each night. The food was secured on a platform some 15-18 feet in the air away from camp. There were bear claw marks 10-12 feet up on the trees holding the platform.

Young Camp Jack, Quinton slipped into our tent each morning at 4am stoking the fire and providing a weather report for the day. A very nice touch to actually wake up and get dressed 45 minutes later in a warm dry tent. We had rain showers

on the ride in and rain and or snow and fog each day for the week. By mid week for each 1-2 inches of snow at camp I thought about the Pass, how much snow was accumulating up there? River, one of the guides shared a photo of himself in Oct 2019...using the shovels along the trail, the snow was THIRTEEN FEET deep! He recalled it took 6.5 hours for him to shovel through roughly a quarter mile of trail that day to get out. Yikes...now I really began to wonder/worry about the pass.



Josh, an ex-marine was my guide. He fit my temperament and enthusiasm perfectly. The first morning we headed 1.5-2 miles north from camp, about 45 minutes in the saddle. Dolly, my horse for the ride in, got the day off resting. The next 6 days my horse/mule was tall enough it required me to find a stump or uphill angle to mount, not the picture of John Wayne cowboy I thought I was. We saw elk daily, a few deer (the migration out of YNP had not started) I saw two grizzlies, a black bear and lots of grizzly tracks and a couple wolf tracks. Others in camp saw more grizzlies on their hunts and we had a griz in camp one day which the cook shooed away. The cook radioed everyone to be on the alert and we were able to see the bear in a meadow near camp through our glass.


Josh earned a few demerits from me early, #1: for hiking me down a steep canyon full of blown down timber up the other side then we had to return back through the same mess. Hiking over downed logs with frosty slick snow is a recipe for getting hurt, I didn't want a \$40K medivac helicopter ride. Demerit #2: he lit a nice warming fire, but he had to use 3 matches to get the wet wood going \bigcirc #3: he hiked me up a steep snow covered slope when the horses were actually tied up down the draw, the extra uphill hiking was not necessary (we both slipped and slid 20-30 feet coming down) demerit #4: he allowed me to lose some of my gear:-a hat, a glove, my shooting sticks and worst of all my truck keys. The other guides enjoyed hearing about the demerits he was racking up each night at dinner. Actually none of those items are lost, I geo-cached them in the back country of WY. So if anyone wants to go on a scavenger hunt after a 31 mile horse ride looking for my "chit" I'd appreciate it if you brought it back to me.

By day two Josh decided to share with me a photo of a 7x8 bull they had been trying to harvest for the past 3 weeks. After seeing the photo this was my target bull for the next 5 days. We found him four of the five days and I actually chambered a round 4 different times moving in on a stalk. Each time the bull would zig when we had zagged and I never got close enough for a shot before he slipped into the trees or he didn't step out where we expected him to be.

One morning we spotted him roughly ½ mile from camp so we left the horses tied up and hiked up to the clearing where he was feeding with 4 cows. He slipped into the trees just as we got to the opening when we could see him again. We sat there in the snow ALL day hoping for a chance he'd be back out later, he didn't show that afternoon. I wanted to be at the small clearing in the dark the next morning to catch him out feeding. Josh held me back saying lets locate him first before making the climb up. The next morning (my last day to hunt) I glassed him in a clearing about 1.5 miles north of camp in

a steep rocky chute above the trees. I was glad Josh had held back my plan of hiking in the dark, however getting to him now would require not 1, not 2 but 3 deep canyon crossings full of blown down timber. One of the same deep canyons Josh had earned a demerit for on day 1 or 2. Neither one of us wanted to go on that death march of a hike and the chances of him being out for 2-3-4 hours while we made the hike were very slim. AND if we did make the hike to sit and wait for him to come out again would he come out? Or would he slip away just like the day before? Generally the crew does not like to hunt on the last afternoon prior to a long ride out. Recovery of a bull late is added work when there is a huge effort to get the hunters and some 20-25 head of stock on the trail early in the morning. But, all the guides were in agreement this bull was one to make an exception. Lots and lots of discussion ensued, I really wanted to try for this bull. The odds of success were VERY LOW, the odds of a brutal hike were VERY HIGH, I also weighed the odds of someone getting hurt along with the extreme effort required to recover the bull IF we were successful.

I made the final decision to hang in camp and get our gear ready for the long ride out in the morning. I was also still concerned about the amount of snow accumulation over the pass. I kept my spotting scope set up to keep an eye on the bull and just a few minutes after making my decision he pushed his cows into the trees. Everyone went to work organizing and packing their gear, chopping some wood and other camp chores. About 2:30 that afternoon I looked back up at the rocky chute....there was the bull again! I went to the guide tent to tell Josh. All the guides came scrambling out and the discussions began all over. It sure was tempting to make a final play on this big bull but all the same issues from the morning made the decision easier...we would not risk it, however had we moved in earlier to sit and wait him out would that bull be on my wall? No one knows? Another group of 8 hunters were scheduled for the next week, I asked Josh to send me photos of that bull when he got him killed. I'm still waiting.



Visibility was zero some days but a warm fire helps for sharing hunting stories, fresh tracks of another hunter ahead of us, staying warm making the firewood, the long ride out as we neared the pass, only 1-1/2 or 2 feet of snow, not 13 feet!

The Image of Hunting bpatterson

Are we as hunters hurting our own cause? Social media has exploded in the past 10 years, EVERYONE has a voice to express their thoughts, feelings, and point of view. Everyone is competing to have the biggest "following" or the most "hits" on a certain post. Posts that at one time were just shared with family and a few close friends via email are now broadcast to the world via Facebook, Instagram, Twitter, TikTok, Snap Chat, YouTube and other platforms.

As hunters we are no different; we want to be recognized, we want to be popular, we want to "show off" our successes in the field. How do we generally accomplish this? With photos of our "harvest". Photos of that first buck, the biggest buck of the year, the pile of snow geese, a long stringer of fish or most recently in the news a stack of dead coyotes from a coyote calling contest. I bring this up as now the movement has turned the corner and is gaining traction with the majority of the general public. They are using these same "hero" photos we share freely against us to paint a picture of wanton killing. The message is being shared over and over on social media "look what hunters do, they kill not just for sport but for FUN"

This past week at the Clark County CAB meeting almost 2 hours of discussion revolved around the general public wanting NDOW to stop coyote calling contest in Nevada. Nine states have already done so, is Nevada next? The sportsmen in the audience held that coyote calling contest are a "management tool" to help curb the population of one of the top predators eating deer fawns and other game species. The non-consumptive users in the audience held that killing coyotes and awarding prizes is simply killing for fun, seldom are the pelts harvested and certainly the meat is not for consumption. The main weapon used against sportsman are photos actually provided by sportsman. Piles of bloody dead animals really play into the emotions of people, it is extremely hard for sportsmen to defend these photos as game management or conservation.

I'm proud of my hunting heritage and proud to display taxidermy trophies in my office and home. In fact I try to mention hunting, shooting or fishing early in a conversation when meeting someone for the first time. The company I work for is based in California and many of my colleagues lean to the left. I proudly have photos and mounts in my office space and freely promote that my PTO will be spent on a hunting trip. I don't cover up my activities or what I believe, I try to educate others on how sportsmen and hunting actually help wildlife populations and that sportsmen are the ones paying to conserve wildlife for EVERYONE to enjoy.

In that same vain using the same platforms that are being used against us, sportsmen should be using Facebook, Twitter, Snap Chat etc to promote the positive things hunting does. I feel we should lessen the amount of "hero" photos that cast us in a bad light. Don't shy away from or be afraid to stand up for your beliefs but think a little bit before posting on social media. How does this image portray us as sportsmen? Does it have a negative impact in anyway? Could it be used against me somehow? Remember Cecil the lion from a few years ago? Walter Palmer the dentist who harvested that lion was crucified in the media, his business was impacted, he received death threats. Do you want that type of exposure?

Sportsman need to unite and stand together on the issues facing us, there will always be a few bad apples that get lots of attention for doing wrong. How about getting attention for doing good.


