Wyoming Game and Fish Commission Approves Tri-state Grizzly Management Plan

The Wyoming Game and Fish Commission took the first step in the process to address the court's concerns to delist grizzly bears in the Greater Yellowstone Ecosystem. The Commission approved a revised tri-state Memorandum of Agreement (MOA) regarding the management and allocation of discretionary mortality of grizzly bears in the Greater Yellowstone Ecosystem.

"Wyoming has worked collaboratively with Idaho and Montana to make these updates," said Rick King, chief of wildlife for Wyoming Game and Fish Department.

The revised MOA recognizes the expanding number of grizzly bears that have grown beyond the edges of the bear's biological and socially suitable range. With refined population estimates, data shows the population numbers more than 1,000 bears, far beyond all scientific requirements for a recovered, viable population. The revisions also include an explicit commitment to grizzly bear's long-term genetic health and will provide for translocation of bears into the population, as needed, to maintain genetic diversity.

The MOA will still need approval from Idaho and Montana through their respective Commissions and directors before Wyoming files a delisting petition to the U.S. Fish and Wildlife Service.

The Rocky Mountain Elk Foundation has steadily maintained that grizzly bears in the Greater Yellowstone Ecosystem (GYE) met all delisting threshold requirements and should be delisted so they can be managed by state wildlife agencies.

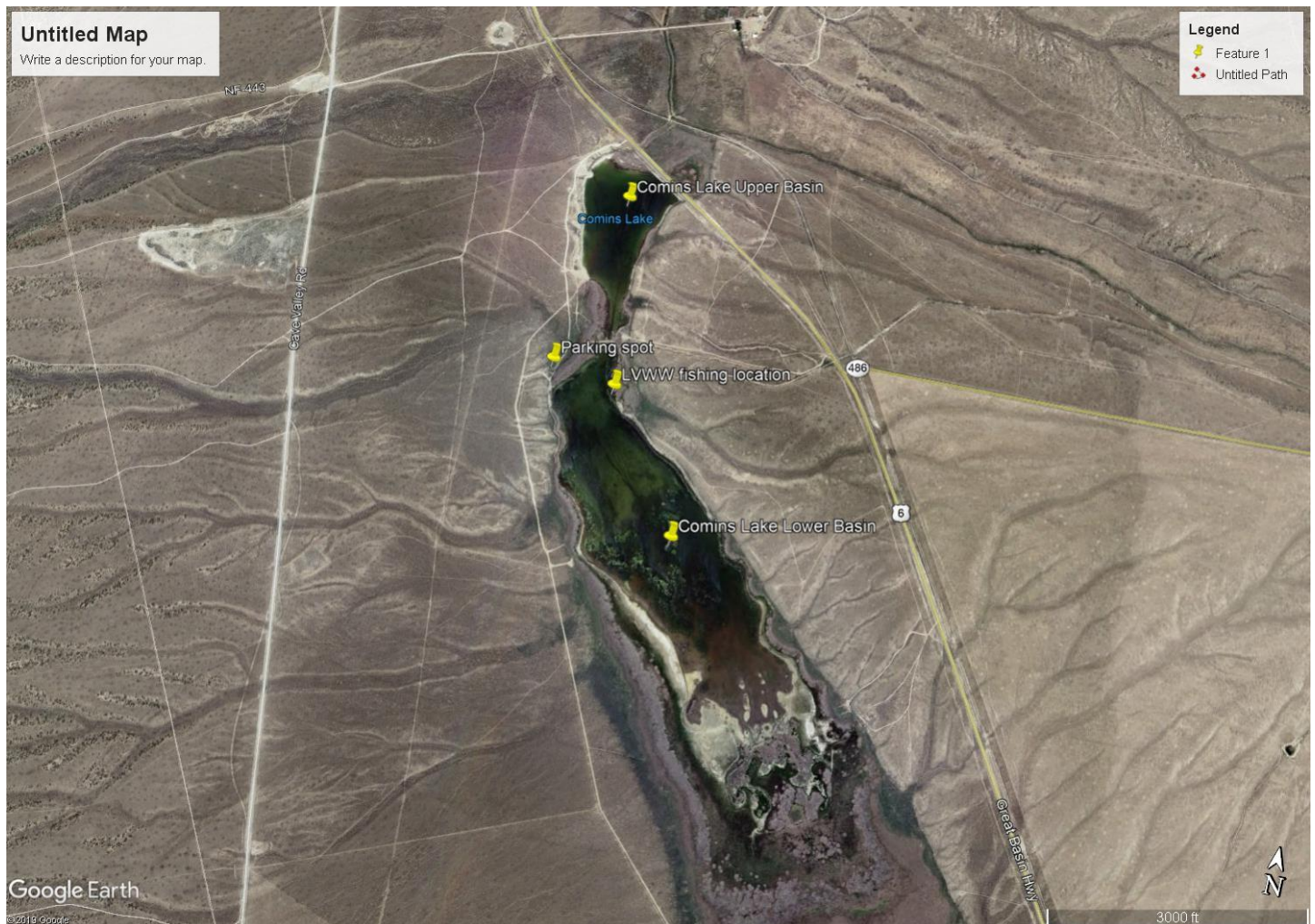
2022 LVWW Angler of Year event in conjunction with ELY ROTARY CLUB FISHING DERBY at COMINS LAKE Feb 5th 8-3pm

The Ely Rotary Club has cancelled their annual Ice Fishing Derby the past couple years. LVWW has tried to hold our event at the same time to piggyback on the festivities, we will do so again this year. Our event is focused on club bragging rights, (we will set rules soon, most fish or biggest fish). LVWW Club members will try to gather around the north end of the lower lake section (maps below) be prepared to be flexible incase the location changes at the Rotary check in on Feb 4th at the Ely Convention Center. We will be drilling holes so all you need to bring is warm clothes and your fishing gear along with a chair. Most years the weather has been very pleasant, actually warm in the afternoon. This is a big SOCIAL event. Parking should be better than at Cave Lake but prepare to be out early.

I **DID NOT** get a block of rooms at **LaQuinta Hotel**, but it will serve as our base location. Book a room for a rate of roughly \$135-140 per night for two queen beds, call 775 289-8833 to make reservations, 2 nights Feb 4 and 5th, also contact The Prospector Hotel at 775 750-0557 or try the Holiday Inn Express at 775 405-4577. Hope to see you there, this is our first 2022 Angler of the Year event.

Our own Boy Scout Troop #130 has served up breakfast along with hot coffee and hot chocolate for us on the ice. I have not confirmed if that will be the case this year. The Rotary will be selling food & alcohol on the ice.



Tentative Western States Big Game Application Dates

LVWW is a “hunting & fishing” club so to promote the hunting portion of the club I have compiled a few of the western states big game application periods. The dates provided below are TENTATIVE you will need to do your own deep dive research if you have an interest in hunting these states or others. The entries in **bold** have been approved by the states game agency, all other dates listed are tentative. I simply list the states neighboring Nevada or the states in which I apply each year. The list is provided in order of the calendar application .

Due March 17	NM	elk, deer, antelope, sheep, oryx

April 1 to April 30	ID	moose, sheep, mtn goat
April 15 to June 2	CA	all species
May 1 to June 5	ID	deer, elk, antelope, fall bear

Due June 14	AZ	deer & sheep



Just like playing the lottery, you can’t win if you don’t play, submitting for numerous species in numerous states is the ONLY way you can assure yourself of drawing a tag each year. Of course there are other opportunities to purchase over the counter or landowner or raffles for tags in some states. Building points for unsuccessful draws will tilt the drawing in your favor over time....for example after applying for almost 20 years, I have 80 preference points in Maine for moose, one day soon I should draw that tag!

Member Dan Zelna, (previously from Ohio), provided these statistics for the 2021 Ohio hunting season...still not complete as of this article. Ohio is not a western state so did not make the list of application dates above, if you wish to be one of the 70,000 plus successful deer hunters in Ohio log onto their website and research how to apply.

Dec. 6—COLUMBUS, Ohio — Ohio hunters harvested 70,413 deer during the 2021 deer gun week that concluded on Sunday, Dec. 5, according to the Ohio Department of Natural Resources (ODNR) Division of Wildlife.

A news release from ODNR stated, over the past three years, hunters checked an average of 65,280 deer during the same weeklong period, which marks an 8% increase in 2021. Deer gun season is open again on Saturday and Sunday, Dec. 18-19.

During the deer gun week, hunters harvested 25,263 bucks (36% of deer taken), 36,096 does (51%), and 8,021 button bucks (11%). Bucks with shed antlers and bucks with antlers less than 3 inches long accounted for 1,033 deer, or 1% of the harvest.

Straight-walled cartridge rifles have become more popular each year since becoming legal for deer hunting in 2014. During deer gun hunting week, straight-walled cartridge rifles were used for 49% of checked deer. Shotguns accounted for 43% of the total. In addition, 6% were taken with a muzzleloader, 1% by archery equipment, and less than 1% with a handgun.

Corner Crossing Conundrum In Wyoming

[Corner crossing is one of the most](#) controversial topics out there right now. Let's define corner crossing as it pertains to this conversation before we go any further. Corner crossing is simply where two pieces of public land share a corner and someone from the public steps from one section of public to the other. In theory and in the eyes of many in the [public land hunting](#) world it would seem that no trespassing has occurred. In the eyes of many landowners they believe that their property has been trespassed on when this happens. Their

understanding is that they have a certain level of ownership above the ground. A quick Google search on this is clear as mud because the definition varies from state to state, but anywhere from 80-500 feet above the ground seems to be where some of the articles settle.

Which brings us to where we are with a case here in my home state of Wyoming regarding corner crossing. In the fall of 2021 Brad Cape, Phillip Yoemans, John Slowensky and Zach Smith were each cited for trespassing by corner crossing from one section of public land to another. The ranch involved is the Elk Mountain Ranch in southeastern Wyoming. According to witnesses the men built a ladder-like device that allowed them to cross several stakes without touching the ground or any "piece" of private physical property in the process. So why were they cited for trespassing? [Well according to the most recent Wyoming](#) legislative statute criminal trespass is what "can" be cited by local law enforcement such as a sheriff if the case warrants it. A Wyoming game warden cannot cite hunters for this as ruled by the Wyoming Supreme court. Every case is investigated on a case by case basis as the 2004 supreme court ruling implicates. Yup, it's more than a little confusing.

The four men are going to fight the citation with financial help in the form of a GoFundme account funded by many public land hunters who want to be able to hunt the public land that tax dollars maintain. Therein lies the crux of the issue...public land that the [public doesn't have access to](#). Essentially private public property if you will that can only be recreated on by the landowners who border it or with permission from the said landowners. With the renewed and increasing interest in accessing public land in the covid era as well as the tools in GPS form that make it very easy to find property boundaries, this has the potential to be a very long litigation. Expect it to be a challenging issue to navigate for all involved.

Grizzly Poached-Google Solves Case
